I further state that I am of lawful age and legally competent to sign this Liability Release Agreement, or that I have obtained consent of a parent or guardian as witnessed by their signature provided below.

I understand the terms herein are contractual and not a mere recital, and that I have signed this Agreement of my own free act and with the knowledge that I hereby agree to waive my legal rights. Any cancellation made within 60-days of the trip will forfeit all payments.

Any refunds will be credited upon departure date.
